HAVING FORMED A FAVORABLE OPINION OF YOUR UNION, I HEREBY MAKE APPLICATION TO BECOME A MEMBER THEREOF AND IF ACCEPTED I AGREE AS FOLLOWS: THAT I WILL REMAIN A MEMBER UNTIL EXPELLED; THAT I WILL NOT VIOLATE ANY OF THE PROVISIONS OF THE CONSTITUTION, RITUALS, BY-LAWS, CUSTOMS, RULES, OR MANDATES OF THE UNION OR ANY CONTRACT OR AGREEMENT WHICH PROVIDES FOR THE WITHDRAWAL OF MY MEMBERSHIP FROM THIS UNION; I FURTHER AGREE IN THE EVENT OF A CLAIMED GRIEVANCE AGAINST THE UNION TO FAITHFULLY OBSERVE THE PROCEDURE OF, AND WITHIN THE PROVISIONS OF THE INTERNATIONAL CONSTITUTION, FULLY ACCEPT AS FINAL THE FINDINGS OF THE TRIAL BOARDS WITHIN THE ORDER; I FURTHER AGREE TO CONFORM TO AND ABIDE BY ALL LAWS, RULES, AND REGULATIONS AND ORDERS STIPULATED IN THE CONSTITUTION AND BY-LAWS, OR GIVEN BY THOSE IN AUTHORITY.
